Down Payment: A down payment of 50% is expected at the time of reservation. Unfortunately, at this time I am unable to accept credit card/debit card payments. Checks are accepted but cash is our preferred method of payment.

Final Payment: The total amount due must be paid two weeks prior to your event date.

Delivery: We encourage our clients to allow us to deliver your wedding cake since it is during the transportation to the wedding hall or setup that cakes become damaged. If an unforeseen event causes a defect to your cake during delivery, it can be quickly fixed as additional tools and supplies are always brought for this purpose. If it is a multi tired cake, it is not uncommon for the tires to shift during transport due to unexpected bumps and stops. For this reason we do not assemble most multi tired cakes prior to transport. If an elaborate assembly is required for your cake presentation it will require a person whom is comfortable with assembly techniques for the various pillars and plates. If the client picks up the cake the additional assurance will not be available if something should go wrong during the transport, stacking or assembly. Delivery is \$10 per hour plus .55/per mile estimated to destination.

Pick Up: If you are picking up a cake we strongly urge you to use a vehicle with a large flat surface and something with fold down seats allowing for air conditioning to reach the cake. Cakes do not like to be hot and will shed their iced coverings in order to cool themselves. Speed is not a factor. Cakes don't care how fast you go as long as you don't slam on the breaks at the light or cause G-forces going around a corner. Never hold a cake in your lap. You will wind up wearing it or will need therapy from the stress. Rural areas – avoid the gravel, washboard and pot hole filled roads or drive very slowly on them.

Additional deposits for stands: Cakes require support and we use heavy duty stands. These stands can be added to the cost of your cake if you wish to purchase them or you may pay an additional deposit. Cake stands must be returned by Wednesday the week following your event or you will lose your deposit. Damage or loss to stands will result in a charge that will be deducted from your deposit. We do not currently have the silver/gold cake stands to rent.

Flowers: We choose to use Valley Floral, 223 North Spruce Street, Valley Ne, 402-933-1800 for our florist. They provide silk and fresh flowers arrangements. If you have ordered flowers for your cake from Valley Floral we are willing to pick them up and arrange them on your cake for you saving you an additional floral delivery charge. If you wish to use your florist we will be happy to provide you with the dimensions of your cake for you to make arrangements with your florist. We will not pick up your florists flowers but will arrange them on the cake IF they are at the reception site at the time of the cake delivery. We are not responsible for the final look of loose flowers but will try to follow your design as close as possible.

Cancellations: A cancellation may be made up to two weeks before the event. In the event of a cancellation the down payment will be refunded within 30 days minus the \$25 “reserve the date” fee. If special items are ordered in advance which are required for your project this amount will also be deducted from your down payment. These items will become the client’s property and will be given to them accordingly.

Guarantee: While we make every effort to provide exactly the flavors, fillings, decorations, sizes, shapes and colors you have requested, the creation of a cake is an art and may be subject to slight variations by the creator(s). I promise you the best product and service I can provide.

Our Obligation: We take our obligation to provide your wedding cake as agreed in this contract very seriously. However, should an unforeseeable event occur which prevents us from fulfilling our obligation and we must cancel our agreement with you, we will refund your payment in-full. In addition, if at all possible we will work with you to find another qualified bakery to assist you with your wedding cake and will cooperate in transferring materials to the new baker.
